#### Review, Modify or Accept Agenda

**Approval of October 10, 2023 Regular Meeting Minutes** – A motion was made by Vice-Chairman Amber Wimsatt, seconded by Secretary Dakota Hufford to approve the October 10, 2023 Regular Business Meeting Minutes as submitted via e-mail. With no further discussion, motion unanimously approved. The original copy of the approved minutes were signed by Vice-Chairman Amber Wimsatt. (2023-047)

**Approval of November 2, 2023 Special Meeting Minutes** – A motion was made by Treasurer Lowell Hanna, seconded by Vice-Chairman Amber Wimsatt to approve the November 2, 2023 Special Meeting Minutes as submitted via e-mail. With no further discussion, motion unanimously approved. The original copy of the approved minutes were signed by Vice-Chairman Amber Wimsatt. (2023-048)

**Bills & Checks -** Bills and Checks were given to Board Members for review and approval. Bills and checks were approved as presented by way of review and signatures.

**Monthly Master Spreadsheet** – A copy of the 'Monthly Master Spreadsheets was distributed to the Board Members. Vice-Chairman Amber Wimsatt and Treasurer Lowell Hanna read the 'Monthly Master Spreadsheets' to the Board Members, a discussion followed.

**Remodel RFP Update** – Executive Director Josh Jacobson informed the Board Members that the 'Remodel RFP Contract' was submitted to CCVCD Legal Counsel and 'LRS'. A discussion followed regarding a kick-off meeting with 'LRS', 'LRS' site visit building walk through of the CCVCD building, and the time frame of the remodel project.

**Deferred Compensation (457B Plan)** – Paperwork regarding deferred compensation percentage rates was given to the Board Members, a discussion followed. A motion was made by Treasurer Lowell Hanna, seconded by Vice-Chairman Amber Wimsatt for CCVCD to offer a deferred compensation match to the full time permanent staff, with a cap match up to 4% of their annual salary pending the employee's participation. With no further discussion, motion unanimously approved. (2023-049)

**Compensatory Time/Overtime Payout** – Tabled until the next Board Meeting in December.

**Discretionary Bonus** – Board Members discussed giving the three (3) full time permanent staff of CCVCD a discretionary bonus. A motion was made by Vice-Chairman Amber Wimsatt, seconded by Secretary Dakota Hufford to pay the three (3) full time permanent staff of CCVCD a discretionary bonus of \$1,500.00 each, for the extraordinary circumstances due to the CCVCD District office moving to a new building location. With no further discussion, motion unanimously approved. (2023-050)

**Board Member Recruitment** – Paperwork was distributed to Board Members regarding 'ABC' applicant Dan Green. A motion was made by Treasurer Lowell Hanna, seconded by Secretary Dakota Hufford, to recommend applicant Dan Green to the Clackamas County Commissioners for the CCVCD Board Member position. With no further discussions, motion approved, Chairman Dan Green abstained from the vote. (2023-051)
